Safety Intervention (s)

- \* If an immediate danger or in the event of child abduction – Monitor will call 911 first.
- \* Monitor will calmly and immediately remove the child/ren from the situation, taking them into a locked room, gain assistance from another party or move child/ren into her vehicle to leave.
- \* Monitor shall have Pictures of the child(ren),
- \* Copies of photo Identification of both parents/guardians.
- \* Contact information of both parents/guardians, authorizations.
